The Annual Report for the South Euclid Municipal Court for the year ending December 31, 2014 is hereby submitted which summarizes the court's finances and caseload as required by Ohio Revised Code Section 1901.14 (A) (4). This report describes the daily operations of Clerk of Court which includes the civil, criminal/traffic and probation divisions. Revenue from the court is generated by fines and court costs assessed and distributed to the State of Ohio, Cuyahoga County, City of South Euclid and Cleveland Metropolitan Park District. Additional disbursements include bond refunds, restitution, rent escrow receipts and miscellaneous refunds for overpayments of fines and costs.

The year 2014 brought many exciting changes to the South Euclid Municipal Court. The Court is still one of only three municipal courts in Northeast Ohio to become "paperless" or utilize technology to store and retrieve case-related information. The scheduling of traffic, criminal, or civil cases for court appearances are now sent by electronic mail (email) to the party's attorney of record and prosecuting or opposing attorney. The rule does not apply to pro se parties or defendants who are considered self-represented litigants.

The court also expanded its internship and community outreach programs. To maximize the effectiveness of Night Court, the sessions are now held the 4th Thursday of the month except for November and December. Students from the South Euclid/Lyndhurst School District selected the New Court Logo which is proudly and prominently displayed on the court's new website. Judge Byers participated in the "Youth in Peril" Community Meeting sponsored by the South Euclid City Council Safety Committee. South Euclid Municipal Court was honored to have an opportunity to assist young people with their career aspirations. Zachery Chaikin, an advanced placement student at Charles F. Brush High School, Terel Walker, a student at ITT Tech, Ericka Cleggett a recent graduate from the University of Phoenix, Sonya Kapour, a law student at Case Western Reserve and Sydney Saffold a law student at the University of Cincinnati, were selected as Interns.

The court participated in a "Can Food Drive" led by our interns. The effort was dubbed the "Bag for A Bag" campaign where the South Euclid Municipal Court teamed with the Cleveland Clinic Foundation to secure more than 500 lbs. of can goods which were donated to the Cleveland Food Bank Harvest for Hunger Campaign. Each participant received a Cleveland Clinic Tote Bag no matter the amount of their contribution.

More than a dozen school and youth groups ranging from students at Greenview Elementary,

ArcTech and Brush High along with others participated in Democracy Days. The program is a special learning experience where schools, community groups and local athletic teams are invited to spend a day at the court to witness, firsthand the important role the court plays in our system of democracy.

The court's total receipts for the year ending December 31, 2014 were \$1,142,562.56. Operating costs of the court paid through the City of South Euclid's General Fund totaled \$643,451.61, the breakdown is as follows:

#### Gayle F. Williams-Byers Administrative and Presiding Judge

Judge Gayle F. Williams-Byers was elected to the South Euclid Municipal Court in November 2011. She is a native Clevelander and is a graduate of Shaw High School in East Cleveland, Ohio. 

### South Euclid Municipal Court Probation Department

#### **Driving Privileges on Bureau of Motor Vehicle Suspensions**

Pursuant to legislation effective January 1, 2004, the court may in certain circumstances, grant limited driving privileges to defendant's who are currently under suspensions imposed by the Ohio Bureau of Motor Vehicles. These suspensions include but are not limited to: 12- point suspensions, failure to pay reinstatement fees and suspensions for driving without insurance. The Court has developed a process though the Probation Department to review and determine eligibility for this type of driving permit. The Probation Department meets with the applicant and outlines the requirements to obtain a limited driving permit. Upon recommendation of the probation Officer, the court may grant a limited driving permit to applicants who demonstrate the need and ability to comply with insurance laws and other Bureau of Motor Vehicle requirements.

#### **Alternative Sentencing Programs**

The South Euclid Municipal Court utilizes several alternative sentencing programs when appropriate for the defendant's convicted of certain offenses. These offenses can include: Operating a Vehicle under the Influence, Domestic Violence, Theft, Child Endangering and Drug Offenses. Some of these programs are described below.

#### **Drivers Intervention Programs**

Defendants convicted of Operating a Vehicle under the Influence of alcohol or drugs (OVI) on a first offense when appropriate, are ordered to complete a 72 hour residential Driver Intervention Program (DIP), as an alternative to serving a minimum mandatory three-day jail sentence. Defendants who attend the driver's intervention program receive intervention through educational lectures, group counseling and individual screening. Upon completion of the program, the Court is provided with a recommendation for further referral services if needed, such as a full drug and alcohol assessment, AA meetings, residential or outpatient treatment. The ultimate goal of the driver intervention program is to help offenders recognize the seriousness of drinking and driving while reducing the likelihood of a repeat offense.

The South Euclid Municipal Court utilizes four drivers' intervention programs: Assessment Consultants, Interchange, Safety through Education and the Steven's Center.

The cost to the defendant for attendance at the above listed program range from \$355 to \$500.00. Defendants convicted of other drug or alcohol related driving offenses such as physical control are often referred to attend driver awareness sessions sponsored by Mothers Against Drunk Driving (MADD). This alcohol intervention program consists of five one hour sessions of guest speakers that focus on the dangers and tragic consequences of drinking and driving. MADD sessions are hosted at thirteen different locations in Cuyahoga, Lake and Lorain Counties, and are usually held once a month at a cost of \$25.00 per class.

#### DOMESTIC VIOLENCE AND ANGER MANAGEMENT PROGRAMS

Defendants convicted of domestic violence offenses are often ordered to attend family violence intervention programs. These programs are designed to educate perpetrators of domestic violence through group counseling, including homework assignments focusing on abusive behavior, anger and control issues and family impact. From time to time, the court utilizes Cleveland Municipal Court's Domestic Violence intervention Education and Training Program (DIET), which is a sixteen-week course. The cost for defendant's to participate in the program is \$80.00.

The Court also utilizes anger management programs designed to educate defendants on appropriate ways to express anger and aggression, teaches defendants how to identify triggers to anger and how to manage

stress through counseling and participation. Anger Management Programs generally consist of weekly sessions of ninety minutes each for a minimum of eight weeks. The South Euclid Court utilizes Blaney Training Group Professional Consulting Services for Anger Management counseling. The cost to the defendant is \$99.00.

#### NON VIOLENT FIRST OFFENDER PROGRAM

Non-violent first offenders with no prior criminal record are eligible for consideration in the court's first offender program. Defendants convicted of offenses such as petty theft, child endangering, underage drinking and minor drug offenses are often placed in the Court's first offender program. The defendant is required to pay a program fee and perform community service hours. Defendants must complete one or more of the following programs: substance abuse educational program, life skills, theft deterrent program and or parenting course.

#### THEFT DETERRENT:

The Theft Intervention Program seeks to assist individuals using an interactive approach to learning. Participants are encouraged to abandon thinking errors that lead to poor decisions and impulses by replacing it with appropriate decision-making skills. The following topics are covered through a variety of methods including lecture, role-play and worksheets.

- 1. Learning to distinguish between needs and wants
- 2. Heightening awareness of the societal impacts of theft
- 3. Examining emotional and legal costs of court involvement
- 4. Dealing with defenses- rationalizations, minimizations, blaming and denial
- 5. Identification of values and morals
- 6. Learning to accept responsibility through self-evaluation
- 7. In depth look at personal attitudes and beliefs
- 8. Learning how to prioritize problems and develop solutions

The course is facilitated by a licensed social worker with more than 14 years employment experience in the criminal justice field. The class meets at the courthouse in a private room set up in a roundtable format allowing participants and the instructor to have a personal connection to the material and one another.

#### LIFE SKILLS:

The Life Skills course is designed to take individual clients through a process that develops and helps enable him or her to achieve critical and personal changes specifically addressing identity, attitude, values and ethics while uncovering personal potential. Life Skills is self-managed learning through interactive activities. The goal is to help individuals learn strategies and how to set future goals. The cost to the defendant is \$120.00.

#### ONLINE COURSE AVAILABILITY THROUGH LRS

The South Euclid Municipal Court is now offering court mandated courses, online. These online courses are available for any offender who is ordered by the South Euclid Municipal Court to complete classwork as part of their sentence. The following are a list of classes offered by LRS: Traffic Level I, \$40.00, Traffic Level II, \$130.00, DUI, \$225.00, DUI Intensive, \$395.00, Alcohol and Other Drugs, \$305.00, Theft Deterrent, \$305.00, Anger Management, \$305.00, and Advanced Anger Management, \$395.00. The defendant is responsible for all cost associated with course.

#### THE CLEVELAND MUNICIPAL COURT SUBBURBAN DRUG COURT PROGRAM

South Euclid Municipal Court is a member of the Cleveland Municipal Court Suburban Drug Court program. South Euclid Court along with Cleveland Municipal Court, Euclid Municipal Court, Rocky River Municipal Court, East Cleveland Municipal Court and Shaker Heights Municipal Court currently comprise the participating courts in this program. Judge Anita Laster Mays is the presiding Judge for

the Specialized Drug Court docket. South Euclid Municipal Court refers low level and non-violent drug and alcohol offenders to the Suburban Drug Court Program.

Offenders referred to Drug Court by the South Euclid Probation Department are assessed by Community Assessment and managed by Recovery Resources. Offenders are given a regular schedule to appear in court. The goal of the specialized docket is to provide a sanction and reward system to encourage long term compliance. The ultimate goal and reward of Drug Court is sobriety and recovery.

Once the offender completes the Drug Court program, the case is returned to South Euclid Court and when appropriate, the record is sealed. The cost of Drug Court is based upon the defendant's ability to pay. South Euclid Court forwards the defendant's Court cost to assist with Drug Court fees.

#### SCRAM AND INTERLOCK DEVICE PROGRAMS

South Euclid Court utilizes alcohol monitoring devices as a condition of granting limited driving privileges to persons charged with or convicted of alcohol related driving offenses. These devices include an interlock device and the Secure Continuous Alcohol Monitoring (SCRAM) device. The ignition interlock device is a breathalyzer installed on the vehicle that requires the defendant to submit to a breathalyzer. This device requires the defendant to submit a breath sample before starting the vehicle. If there is a positive alcohol reading, the vehicle will not start. The device also requires the defendant to submit to a rolling rest once the vehicle has been started. The Probation Department receives monthly reports from the reading or failed test. The cost of the ignition interlock is \$75.00 installation and \$70.00 monthly. South Euclid Court utilizes Ohio Interlock.

The SCRAM device can be mandated by the Court as an alternative or in addition to jail as well as a condition of limited driving privileges. The SCRAM device is a bracelet that is installed on the defendant's ankle that captures transdermal alcohol readings twice in an hour by sampling perspiration collected from the air above the skin.

This is a continuous alcohol monitoring system that increases offender accountability. SCRAM monitors the readings and provides the probation department and Court with a report of any alcohol violations. The cost of SCRAM is \$100.00 for installation and \$12.00 per day while in use which the defendant is required to pay.
