The Court FINDS that in order to carry out such program pursuant to Ohio Revised Code Section 1901.26(B)(1)(a), the Clerk shall add the sum of Twenty dollars (\$20.00), in addition to the fee now being collected for the Court Special Projects, to the Court's schedule of fees and costs upon the filing of each criminal cause, civil action or proceeding, or judgment by confession, with the moneys to be paid to the City of South Euclid, who shall place such funds in a separate account for Records Retention, Storage and Future Capabilities of Same.

It is ORDERED that the South Euclid Municipal Court Clerk, commencing forthwith, collect the additional court costs as hereinabove contained.
